User/Group shall hold Walla Walla Valley Academy harmless for any and all liability from User/Groups use of the facility. Walla Walla Valley Academy reserves the right to cease any activities and require User/Groups to leave premises if deemed necessary. Walla Walla Valley Academy assumes no liability for lost, damaged or stolen item of the User/Group or its owners, agents or employees against any and ll claims of loss, damage to person or property including claims made by the employees of the User/Group and or itsagents arising out of activities conducted by User/Group and or its guests in Walla Walla Valley Academy buildings, property or facilities.
